Exhibit Terms and Conditions:

1. All Works submitted for display must be for sale and completed on-site during this event.
2. Works sold by the artist on-site and before submission are subject to the same financial terms.
3. Gallery-wrapped canvases are permitted, no staples showing, please.
4. Artists will provide finished work fitted with wire and hanging hardware. Sawtooth hangers are not permitted. Artwork requiring a pedestal shall be supplied by the artist.
5. The Sales and Display Committee reserves the right to refuse any work considered inappropriate.
6. Artists will determine the sales price of their submitted work(s).
7. The ELC will transact the sale of works to buyers and will collect and remit sales tax. The ELC will retain 40% of the sales price. Artists will receive payment from the ELC for 60% of the sales price within 30 days after the sale.
8. The ELC and CCIRC reserve the right to photograph and document any submitted artwork. If published, a copyright symbol will be placed on the image and artists will be credited for their work.
9. The ELC will supply beverages. Please bring your own lunch. Refrigeration will be provided.

Liability Acknowledgement:

The ELC and the CCIRC will make every effort to protect exhibited pieces but are not responsible for damage or loss. I understand that I am ultimately responsible for my person, my art and my belongings at all times.
