Exhibition Dates in 14th Avenue Galleries: Wednesday, August 1, 2018 – August 8, 2018

A Bond Unbroken Event : Wednesday, August 8, 2018, 5:30 pm – 8:00 pm

Event Location: Heritage Center, 2140 14th Avenue

Complimentary admission: For Participating artists

Silent Auction: Throughout evening

Awards: All art work will be displayed and entered into a silent auction and judged; the 1st, 2nd, and 3rd place works will be recognized by Meritorious Service, Commendation and Achievement ribbons.

Qualifications: All Artists are welcome to submit up to two (2) entries each.

Theme: Artwork inspired by the Vietnam War and chronicled by the documentary, *A Bond Unbroken*. All mediums are welcome

Artwork must not exceed 60" in any direction including frame and must not exceed 30 lbs. in weight. All pieces must be framed or gallery wrapped (Gallery wrap must be 1 1/2" deep and painted/finished on sides. Artists are to provide their own easel or display surface.

Application Fee: \$10 for each piece entered.

All artwork must be for sale. 50% of the sale price of each piece will go to the artists; 50% to the nonprofit organizations listed above. Artists will be paid within 30 days of the closing of the exhibit. Sales tax will be paid by the buyer and submitted to the nonprofit organization for filing and payment. An artist may donate their income to the nonprofit organizations, but are not required to do so.

Artists Timeline:

Complete Application and fee: Due July 15, 2018 and mailed or delivered to Cultural Council of Indian River County, 2041 14th Avenue, Vero Beach. Make checks payable to Cultural Council of Indian River County.

Checkin: Tuesday, July 31, 2018 to Flametree Clay Gallery, 2041 14th Avenue, between 10:00 am and 2:00 pm; you will then be directed to your designated 14th Avenue Gallery for display.

Deliver artwork to designated Gallery. Tuesday, July 31, 2018 deliver artwork and completed Receipt for Art Work form to designated gallery on 14th Avenue between 11:00 am and 4:00 pm.

Auction & Reception: Wednesday, August 8, 2018 5:30 pm – 8:00 pm

Pick Up Unsold Artwork: Thursday, August 9, 2018 10:00 am – 12:00 pm at the Heritage Center
